INTRODUCTION

Friends.

For nearly 25 years, the American Legislative Exchange Council (ALEC) has published the *Report Card on American Education*, ranking the states based on a variety of performance indicators in K-12 education. I am excited to introduce the next generation of this important publication, *The ALEC Index of State Education Freedom: A 50-State Guide to Parental Empowerment*, which will take its place moving forward. This new publication is forward-looking and evaluates each state on essential policies that change students' lives by empowering parents and families with choice in education.

The COVID-19 pandemic sparked a complete reimagining of how and where students are taught around the country. More importantly, the pandemic sparked a national realization that our current "one-size-fits-all" system of public education simply does not work for too many students. While there are plenty of students who perform at their highest level in their local public schools, there are also many who would perform better in an alternate educational environment. Parents are best positioned to know where and how their children learn best, so we must empower them with as many educational choices as possible.

Public education dollars can and should follow students, not the system. In that spirit, our reimagining of the *Report Card on American Education* focuses exclusively on the policies each state has in place to ensure their students can access the best educational environment for them. We no longer look at things like student test score data, for example, because it can be strongly influenced by student demographics, income, and other factors. Instead, our goal is for this new publication to look to the future by highlighting the state policies that maximize parental empowerment, education freedom, and student achievement. Details on our new ranking and letter-grade systems can be found in the methodology section.

We hope that this publication will serve as a resource for parents looking to learn more about the programs available in their states, and for state policymakers who are looking to expand the educational options available to families. 



Funding and Financing Programs

In addition to making it easier for families to access other educational choice options like virtual schools, home schools, charter schools, and more, states need to make sure that dollars follow these students to whatever educational environment is best for them. This category looks at education scholarship account (ESA) programs, vouchers, and tax-credit scholarship programs that enable students to attend their school of choice, with an emphasis on universal programs that all students can utilize. These rankings are based on program data from EdChoice¹.





Charter Schools

Charter schools are tuition-free public schools that operate without the same regulations given to traditional public schools. In exchange for this freedom to innovate, charter schools commit to obtaining specific learning goals. So long as these goals are met, the charter school can continue to operate. A state earns top marks in this category when the growth of charters is not capped, when a universal and/or non-district authorizer is available, and when charter schools receive similar funding to their traditional public-school counterparts. These rankings are based on data from the National Alliance for Public Charter Schools' Charter Law Database².





Homeschooling

Homeschooling is perhaps the most customizable and tailored approach to learning for students. Thanks to this flexibility, homeschooled students receive a unique educational experience that is parent-led and primarily home-based. State laws should allow these parents maximum flexibility to teach their students in the best manner possible by minimizing burdensome regulations. States earn an "A" when regulations that can impede the homeschooling experience, like testing, academic, or notification requirements, are not present. These rankings are based on data from the Home School Legal Defense Association³.





Virtual Schooling

Virtual schools offer online classrooms where students are taught by teachers certified in online pedagogy. The software used in these virtual schools is specially tailored to an online learning environment. This should not be confused with the emergency crisis remote learning utilized by many public schools when they transitioned to "Zoom learning" during the COVID-19 pandemic. The best states for virtual schooling have options available statewide and across school districts. These states also require some online learning to graduate high school and provide an approval process for online providers and courses. These rankings are based on data from the Digital Learning Collaborative⁴.





Open Enrollment

Open enrollment refers to policies that allow students to attend a traditional public school outside of their designated attendance zone. There are two types of open enrollment: interdistrict and intradistrict. Interdistrict open enrollment policies allow students to transfer to a traditional public school outside of their assigned school district. Intradistrict open enrollment policies allow students to transfer to another traditional public school outside of their attendance zone but still within the same school district. The best open enrollment policies permit both inter- and intradistrict open enrollment while mandating that school districts participate in these programs, subject only to reasonable limitations like classroom space. These rankings are based on data from the Education Commission of the States⁵.

Overview

The ALEC Index of State Education Freedom ranks each state based on the availability of various educational environments, including charter schools, homeschooling, virtual schools, and public schools (through open enrollment policies). The index also takes a look at the financing programs that each state has available to families and rates them based on how many families are able to take advantage of it and how much funding is provided.

Too many communities around the country utilize a "one-size-fits-all" system of education, assigning children to a public school based on nothing more than a street address. This arcane method neglects the unique and individual needs of each student and fails to recognize that, while many students will succeed and thrive in their local public school, many will also experience more success through various non-public educational options.

The goal of this publication is to offer a comprehensive look at the educational options available to American families and, most importantly, demonstrate where each state can improve and keep pace with their peers. We hope that this newly reimagined publication serves as a resource to the dedicated policymakers around the country who are looking to expand freedom in education for their constituents.

Category 1: Funding and Financing Programs (20 Points)

Education Scholarship Account (ESA), voucher, and tax-credit scholarship programs are individually graded on a 20-point scale. The program with the highest score represents the state's overall score for the funding and financing category. Since ESAs are far superior to vouchers and tax-credit scholarships thanks to their enhanced flexibility, these programs are awarded a 5-point bonus.

- Each program starts with 20 points. Subtractions are then made in the following manner:
- 5 points are deducted if funding for the program is not tied directly to the state's education funding formula. This ensures that scholarship values keep pace with traditional public-school funding.
- 5 points are deducted if an enrollment cap is present, regardless of how high or low it is or if the cap increases by some amount over time.
- 5 points are deducted if either of the following is true:
 - There is a cap present on the program's individual scholarship values, unless the cap is at least 90% of the funds that would have otherwise been spent to educate the student in their local public school; or
 - There is a cap present on the program's total funding.
- 0.25 points are deducted for every 1% of the state's student population that is not eligible to participate in the program.

Intradistrict Open Enrollment

- 5 points are awarded for permitting intradistrict open enrollment.
- 4 points are awarded when school district participation is mandatory for any student.
- 1 point is awarded when school district participation is mandatory, but only for certain students.

Interdistrict Open Enrollment:

- 5 points are awarded for permitting interdistrict open enrollment.
- 4 points are awarded when school district participation is mandatory for any student.
- 1 point is awarded when school district participation is mandatory, but only for certain students.

Note: For both types of open enrollment policies, no points will be subtracted when student participation is restricted based on 1) capacity/size limitations or 2) desegregation orders. Additionally, no points will be subtracted when certain groups of students are prioritized for open enrollment spots so long as the school district must accept applications from all students.

TieBreakers

- **Step 1.** Count the number of scoring categories that were non-zero. The state with the higher number wins. For example, if state A scores a total of 20 points in one category and state B scores a total of 20 points in 3 categories, then state B wins.
- **Step 2.** Look at the highest score for each state among all categories. The state with the highest number wins. For example, if state A scored a 10 points in two categories for a total of 20 points while state B scored 15 points in one category and 5 points in another, for a total of 20 points, then state B wins.
- Step 3. Use the same procedure in step 2 but with the second highest scores.
- **Step 4.** Use the same procedure in step 2 but with the third highest scores.
- Step 5. Use the same procedure in step 2 but with the fourth highest scores.
- Step 6. Use the same procedure in step 2 but with the fifth highest scores.

Letter Grading

In addition to its total score, each state received a letter grade that was awarded in the following manner:

- States scoring in the 95th percentile (above 85.43) received an "A"
- States scoring in the 75th-94th percentile (between 57.25 and 85.42) received a "B"
- States scoring in the 50th-74th percentile (between 42.6 and 57.24) received a "C"
- States scoring in the 25th-49th percentile (between 35.25 and 42.59) received a "D"
- States scoring in the 0-24th percentile (between 0 and 35.24) received an "F"

Financing programs were graded on the following scale:

- Programs scoring in the 90th percentile (above 17.50) received an "A"
- Programs scoring in the 80th percentile (between 12.40 and 17.49) received a "B"
- Programs scoring in the 70th percentile (between 9.20 and 12.39) received a "C"
- Programs scoring in the 60th percentile (between 5.40 and 9.19) received a "D"
- Programs scoring below the 60th percentile (between 0 and 5.39) received a "F"

All other categories were graded on the following scale:

- Scores of 20 received an "A"
- Scores between 15 and 19.99 received a "B"
- Scores between 10 and 14.99 received a "C"
- Scores between 5 and 9.99 received a "D"
- Scores below 5 received a "F"

Notes:

Partial, zero, and/or estimated scores were utilized where necessary. The average total score among the states was 46.67 and the median was 42.6.
