Participants explored critical issues like education reform, economic resilience, and combating progressive policies, culminating in the review of a record 82 draft model policies. 
STATE CHAIR FLY-IN

Our first annual State Chair Fly-In was a great success. ALEC leaders from across the nation, including ALEC National Chair and Kansas Senate President Ty Masterson, gathered at our new headquarters for intensive workshops and seminars. During a visit to Capitol Hill, ALEC State Chairs hand-delivered a letter signed by more than 400 state legislators from 45 states, highlighting the benefits of permanently extending the 2017 federal tax cuts.



SOUTHERN BORDER EDUCATIONAL WORKSHOP

In April 2024, ALEC CEO Lisa B. Nelson and National Chairman, Kansas Senate President Ty Masterson led a contingent of ALEC Board Members from across the nation on an educational workshop at America's southern border. The group traveled to witness operations at Eagle Pass, Texas, led by former ALEC National Chairman, Texas State Senator Phil King. As part of the continuing commitment of ALEC to providing members with the best education, they heard from the Texas Department of Public Safety, the Texas Military Department, and others in hope of better understanding what is truly happening at the southern border.



UTAH POLICY DAY WITH DR. ART LAFFER

In May, Utah Senate President Stuart Adams hosted us in Salt Lake City for our Utah Policy Day with Dr. Arthur B. Laffer. Joined by more than 70 Utah legislators, presentations and discussions focused on how Utah has held the top spot for all 17 editions of the Rich States Poor States: ALEC-Laffer State Economic Competitiveness Index and how to further improve the Beehive State's growth trajectory.



BRIEFING OKLAHOMA GOV. STITT

In September, Oklahoma Governor Stitt invited ALEC Executive Vice President of Policy and Chief Economist Jonathan Williams and ALEC Senior Director for the CIED Task Force Gretchen Baldau to discuss economic competitiveness and regulatory reform. While Oklahoma is already a top 10 state for economic outlook, maintaining good reform can continue its upwards trajectory, and we were honored to join the conversation to share the research and success stories behind proven ALEC policy solutions.



ALEC IN TAIWAN

In 2024, as part of the ongoing commitment of ALEC to global freedom and security and to strengthening international relationships with trusted nations, a tri-partisan delegation of ALEC members and staff representing eight states traveled to Taiwan in a demonstration of support for Taiwanese sovereignty and democratic values. The visit underscored the importance of defending Taiwan amidst growing Asia-Pacific geopolitical tensions.

Discussions with key officials, including a briefing with Taiwan's Vice President, gave the group a deeper understanding of the challenges Taiwan faces. The program inspired these ALEC leaders to develop policies to reinforce the US-Taiwan strategic and economic relationship by maximizing trade and working together to secure vital international supply chains for critical items like semiconductors and rare earths minerals. The group also pledged to counter China's exclusion of Taiwan from international institutions.



Coalition Building

Education Freedom Alliance

In January 2024, ALEC launched the Education Freedom Alliance – a coalition of like-minded organizations and state legislators supporting the rights of parents to choose the option that best fits their child's unique educational needs. Co-chaired by Iowa Gov. Kim Reynolds and former Arizona Gov. Doug Ducey, the Alliance hosts monthly strategy calls and convenes in person during the ALEC Annual Meeting and States and Nation Policy Summit. Judicial Deference Coalition

ALEC launched the Judicial Deference Coalition in the wake of the 2024 Loper Bright decision, where the Supreme Court prohibited federal courts from deferring to agency interpretations of the law when ambiguous. However, only 13 states explicitly prohibit judicial deference to state agency interpretations, leaving the issue very much alive in the states. The ALEC Judicial Deference Coalition convenes monthly to assist legislators motivated to tackle deference reform by connecting them with trusted ALEC policy solutions and successful deference reformers to help develop best practices.

ALEC Government Efficiency Coalition

During the 2024 States and Nation Policy Summit, we announced the creation of the ALEC Government Efficiency Coalition and began to solicit input on the best and brightest ideas for government waste reduction from our members and allies across America. As we know, if President Trump's DOGE effort is successful, it will mean that state and local governments, charitable organizations and private citizens will have much more work to do. Policy Solutions in Action

For over fifty years, ALEC has stood as the leading platform where state legislators from across the nation gather to develop effective policy solutions grounded in the core values of American liberty. In partnership with business and policy leaders, lawmakers work together to create innovative strategies that embody freedom and strengthen communities nationwide. Some of the most impactful policies have centered on critical areas such as Economic Competitiveness, Education Freedom, Functional Federalism, Protecting Individual Liberty, Infrastructure, Healthcare and International Relations—each contributing to a more prosperous and empowered America.

Economic Competitiveness

STATE TAX REFORM

ALEC continues to lead the way in the state tax cut revolution across the nation with fourteen states implementing a reduction in individual tax rates. A tax system that allows citizens to keep more of what they earn spurs increased work, saving and investment. All taxes matter for economic growth, but taxes on capital, including business and individual taxes, have the largest negative impact on economic outlook.

In recent years, many states have taken bold steps to provide substantial income tax relief. Notably, 26 states have actively worked to reduce their income tax burdens. As these tax cuts take effect, neighboring states face growing pressure to enhance their economic competitiveness by simplifying their tax codes and aligning them more closely with the ALEC Principles of Taxation.

MAINTAINING ENERGY RELIABILITY AND AFFORDABILITY

While global instability upended energy prices throughout the world last year, now is a chance for governments to make sensible, market-based decisions concerning the costs and reliability of fuels and infrastructure that power our nation.

In 2024, Utah Governor Spencer Cox signed the "Electric Generation Facility Closures and Reliability Act" into law. This legislation empowers Utah to counter federal attempts to close the state's power generation facilities, thereby safeguarding electric reliability. The bill was championed by Utah Representative Colin Jack and Senator Ronald Winterton, who were recognized as ALEC Policy Champions for their efforts in protecting electric reliability.

Virginia Governor Glenn Youngkin, along with Secretary of Natural and Historic Resources Travis Voyles, Senator Richard Stuart, Senator Ryan McDougle, and Delegate Tony Wilt, led the initiative to remove Virginia from California's electric vehicle (EV) mandate. This move was a significant victory for Virginia's autonomy and the interests of its citizens, aligning with the ALEC principles of state-led energy security.

Both actions reflect a commitment to energy policies that prioritize reliability, affordability, and state sovereignty, aligning with ALEC model policies such as the Affordable, Reliable, and Clean Energy Security Act.

Education Freedom

State lawmakers are increasingly recognizing that no single type of school can meet the needs of every student. While some students may thrive in their local public schools, many others will reach their full potential and become more productive citizens by attending private schools, homeschooling, charter schools, virtual schools, or micro-schools. States should not limit access to any valid form of education. Instead, they can help ensure a brighter future for all students by making education funding more flexible, allowing it to follow each student to the learning environment that best suits their needs.

As of 2024, 12 states have enacted programs that provide universal education freedom to families. These states include West Virginia, Arizona, Arkansas, Iowa, Utah, Florida, Ohio, Indiana, North Carolina, Oklahoma, Alabama, and Louisiana.

Protecting Individual Liberty

Following the end of Chevron deference, states have become increasingly focused on judicial reform. With federal courts now prohibited from deferring to agency interpretations of the law, many states are eager to adopt similar measures. Several states took steps toward reform even before the 2024 Supreme Court ruling. In 2024, Idaho, Indiana, and Nebraska eliminated judicial deference, while Iowa, Louisiana, and Oklahoma made efforts in that direction. North Dakota recently addressed issues surrounding administrative law judges, and Indiana successfully implemented reforms to enhance the independence and accountability of their regulatory adjudicating bodies.



Building Better Communities


VETERANS JUSTICE

Veterans often face considerable challenges after completing their service to our nation. Tragically, some become entangled in the justice system, with issues and behaviors linked to their service experience. It is essential for courts to consider these unique circumstances and offer alternative pathways for adjudication, all while ensuring accountability. The ALEC Veterans Justice Act provides a model for states to achieve this. In 2024, Nebraska took a significant step by leading the way in implementing this approach.

SOCIAL MEDIA AND YOUTH ONLINE SAFETY

Children's online safety was a top issue across the state legislatures in 2024 and remains a critical priority for parents, educators and government officials nationwide. Although some policy solutions like strict age verification mechanisms are often crafted with noble intentions to protect children online, some stakeholders have raised concerns about the unintended consequences of excessive government intervention in social media platforms and likely First Amendment concerns.

ALEC members offer a better approach that puts parents in the driver's seat and aims to prepare teens for the digital world by incorporating digital literacy and Internet safety into the school curriculum. Notably, Florida, Georgia, Mississippi, and Tennessee have passed laws requiring platforms to implement restrictions on minors' social media accounts.



Healthcare

PRICE TRANSPARENCY

Providing patients with more information—and, as a result, more control over their healthcare—is crucial to reducing healthcare costs. Healthcare is one of the few industries where consumers are often expected to purchase services without knowing the cost upfront. By making prices transparent, competition increases, driving prices down. Laws passed on a bipartisan basis in states like Ohio, Virginia, Texas, Rhode Island, and Colorado empower patients to take control of their care, plan for their healthcare needs more effectively, and shop around for the best value and price.

International Relations

CHINA'S THREAT POTENTIAL

China has devised a plan and is accelerating a highly sophisticated strategy that has identified state and local governments as a tool to undermine the states and nation. While the federal government has mechanisms in place to protect national security, the states are highly vulnerable to Chinese influence campaigns through the United Front and other entities; China's acquisition of US rural lands; and the homeland security risks inherent in Chinese-manufactured technology.

In 2024 a resolution was proposed specifically to oppose China's manipulation of United Nations General Assembly Resolution 2758 to bar Taiwan from critical bodies such as INTERPOL and the International Civil Aviation Organization (ICAO). ALEC reaffirmed its commitment to supporting Taiwan's sovereignty and constitutional self-governance, highlighting the broader implications for global governance and the rules-based international order.


STANDING WITH ISRAEL

As our friends and allies in Israel continued their campaign to remove the threat of Hamas, ALEC continued our support of America's most important ally in a strategically significant corner of the world. More than 250 legislators from 43 states signed on to our letter stating our unwavering commitment to the welfare, security, and survival of Israel while calling on President Biden to increase America's support for the Jewish State.



Publications

ALEC produced and launched numerous influential policy publications in 2024, including the 17th Edition *Rich States, Poor States*; 2025 Essential Policy Solutions; Myths vs. Facts series; 2nd Edition of Labor Reform Policy and 6th Edition of Other Post-Employment Benefit Liabilities. These educational resources, built upon the ALEC nonpartisan research and analysis, offer valuable insights into the factors that enable certain states to thrive, while highlighting choices that may hinder growth.









RICH STATES, POOR STATES LAUNCH IN NEW YORK

On Tax Day 2024, the ALEC Center for State Fiscal Reform team traveled to Albany, NY to meet with policymakers and highlight the effects of Americans voting with their feet. Our brand-new 17th Edition Rich States, Poor States: ALEC-Laffer State Economic Competitiveness Index focuses on the big government policies that are driving New York's economic woes: For 11 years in a row and 15 out of 17 editions of the publication, the Empire State has ranked dead last for Economic Outlook. Behind this rock bottom ranking are 15 policy variables, including the highest personal and corporate income tax rates in the nation. We were grateful to our friend, Assemblyman Robert Smullen for hosting such a great event.


